The following comments apply to the entire document:

- G1:** All hyperlinks should be checked to ensure that obsolete references currently in ISO/IEC 18024-4:2006 are replaced by up-to-date references. Change instructions to affect this should be added to the amendment.
- G2:** It is not clear that the hyperlink to the publicly available standard is correct once the amendment has been approved. If the amendment is to be published as a new revision, the hyperlink should be updated. If the amendment is to be published as an amendment, the hyperlink should be replaced by a hyperlink to the home page for publicly available standards.
- G3:** Change instructions should be provided for any additional changes to ISO/IEC 18023-1:2006/Am1:201x that effect this document.

- T1:** The reference for ISO/IEC 18023-1 with amendment is incorrect. It should be "ISO/IEC 18023-1:2006/FDAM Am1:201x".
